Up to 3 smoke alarms at \$5 each and one carbon monoxide detector at \$5 (and a second for \$10) can be requested. Proof of home ownership and/or income is required. 

Celebrating 118 Years of The National Western Stock Show

Since 1906, the National Western Stock Show has been held at the National Western Complex in Denver each January. For the last 118 years, the show has been a staple celebration of Colorado's beloved Western tradition and agricultural heritage. The first day always starts with a parade of more than 30 long-horn cattle down 17th Street. Each of the following 15 days has a packed schedule of 10 to 20 events, such as horse shows, rode-os, dancing (square, line, round, swing), livestock auctions, and even the state's largest Western trade show. Known as the "Super Bowl of livestock shows," there truly is something for everyone at the National Western Stock Show.

The annual, historic event aims to strengthen American agriculture through education and enrichment programs, celebrate Western lifestyles and communities, and be a source of long-lasting memories and family traditions. The Stock Show helps the local economy; their website boasts support of "\$171 million in net economic activity in 2023 across the state of Colorado" from the 702,698 attendees and thousands of participants that year. The group responsible for the Stock Show, the Western Stock Show Association, is a 501(c)(3) nonprofit that provides scholarships in agriculture and veterinary medicine practice in rural areas for both college and graduate levels.

Although January in Denver has been synonymous with the National Western Stock Show for the last 118 years, this wasn't always the case. There were multiple attempts to host a stock show in Denver before 1906. Some were successful, like the Denver Blood Stock Association's Blood Stock Fair on June 30, 1874. Still, there was no regular occurrence of stock shows in Denver until the 1906 Western Live Stock Show, which is the beginning

The show has remained a popular event throughout its 118-year history, with a record attendance of 726,972 people in 2006. Despite a COVID-19 pandemic-related cancellation in 2021, attendance has been upwards of 633,000 most years since. Although this year's show ended on January 21st, you can look forward to the 2025 show on January 11th through 26th.

Jefferson County Sheriff's Office

Hello! I am the Community Relations Manager for the Jefferson County Sheriff's Office (JCSO). I am a true Colorado native and I have lived in Jefferson County for over a decade. Using a variety of traditional and non-traditional communications tools, such as Nextdoor, we strive to communicate important information about our services and initiatives to you, our citizens, through various programs and community events. By engaging with community groups of all types, our goal is to garner information and feedback from you to help make Jefferson County a safe place to live, learn, work, and play. #Jeffco Community!

This is a friendly reminder that as of September 2023, it is unlawful to park any major vehicle on any public roadway in unincorporated Jeffco, except for loading, unloading, or other immediate and active use. The good news is that recreational vehicles and trailers are not entirely banned. However, they can only be parked on the road for a maximum of seventy-two (72) hours within a seven-day period. If a vehicle is found violating the county ordinance, we will place an orange notice on it. The owner may receive a ticket and the car will be towed if it is not removed from the public roadway. A recreational vehicle is any vehicle that has temporary living quarters, and the term 'trailer' includes boats on a trailer and any other items, such as cars, trash, and trees. Remember that no vehicles of any type should park in a bike lane at any time. If you notice any illegally parked vehicles, you can report them by calling 303-271-0211 (https://www.jeffco.us/614/Recreational-Vehicles-Parking
